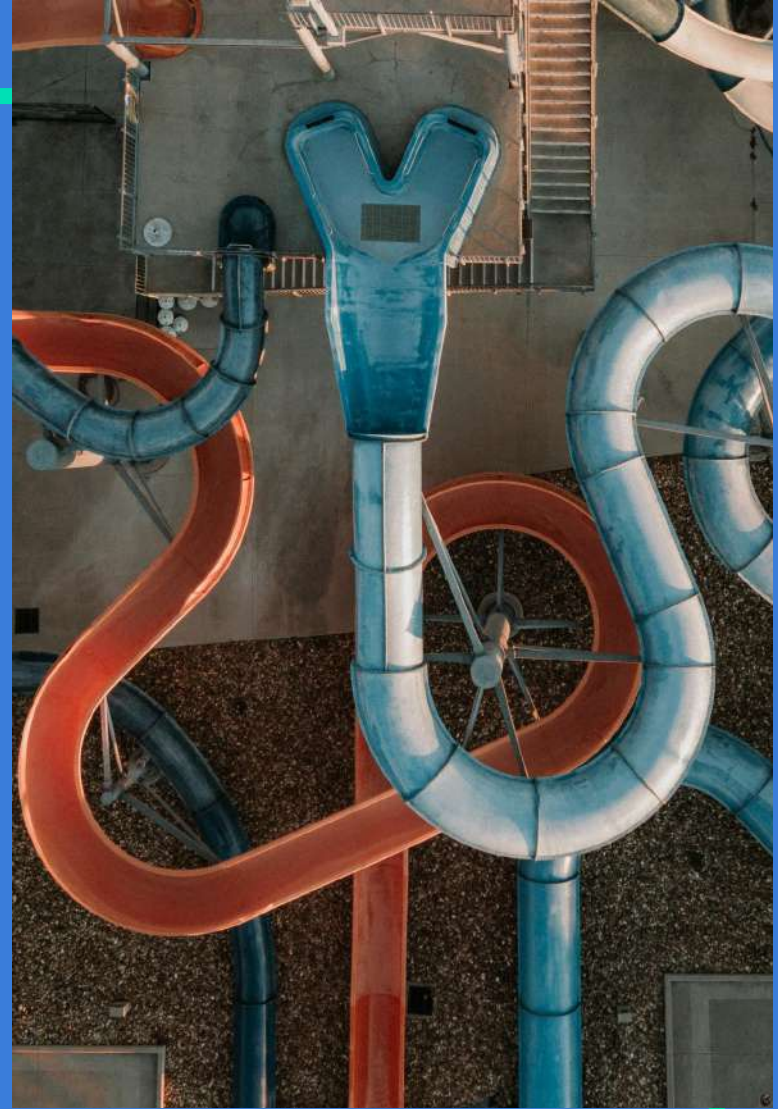
Relationship with touroperators

Additionally, **we collaborate with ABTA as a Health and Safety consultant**, working with them on the development of protocols related to this type of installations.

As a result, all inspections and certifications conducted by The Fun Lab, in parallel with tour operators, are validated by the company to ensure the safety of the hotel's facilities in question.

Therefore, any inspection process initiated, as well as once certification of the facilities is obtained, will be internally notified by us to the tour operator for their records, thus nullifying future preventive audits by them.

Our services summary

We implement comprehensive safety measures in the areas of slides and water equipment for each project.

1. Review of technical documentation associated with relevant regulations. Analysis of structural calculations provided by the supplier.
2. On-site inspection of aquatic facilities. Technical advice related to inspection and resolution of incidents.
3. Issuance of annual certificate of favorable inspection for aquatic leisure areas by an entity accredited by ENAC/ILAC for applicable regulations.
4. Use of the Safe Fun seal, Aquatic Leisure Certification. Communication campaign associated with certification.
5. Notification to [TUI and Jet2Holidays](#) of the initiation of the process and subsequent certification of the facilities.

Inspection and certification

As an internationally accredited entity, our proposal includes the annual technical certification and inspection of water slides, water parks, and aquatic play equipment at the establishment according to applicable European EN standards.

Once it's confirmed that all parameters meet the requirements outlined by the reference regulations, the proposal includes issuing a favorable inspection report, along with a digitally formatted compliance certificate for each installation by an accredited inspection entity.

In essence, this constitutes legal recognition as evidence of regulatory compliance.

Technology applied to inspection

For the audit of water slides, we have a unique technological tool in the market that allows us to **digitally obtain parameters associated with speed and acceleration**, geolocating different points of the slide, thus ensuring that they are within the safety ranges established in the regulations.



International recognition

Our inspection process is suitable for any establishment worldwide that wishes to adhere to an official certification of international standards, provided that the country in which it is located has its public accreditation body as a signatory member of the International Laboratory Accreditation Cooperation (ILAC) mutual recognition agreement.

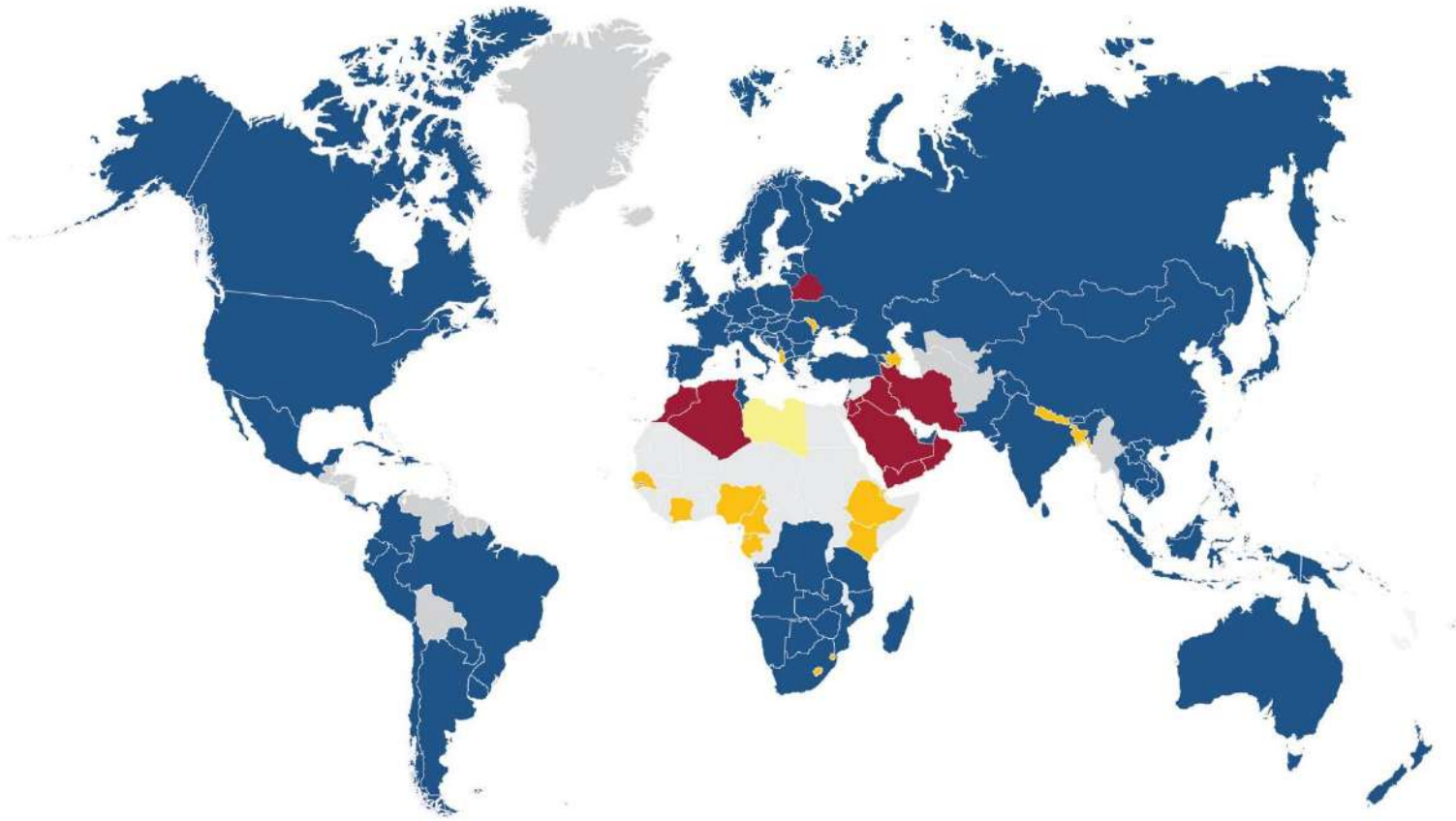
This way, The Fun Lab's expertise as an official and independent inspection body is recognized internationally, both for the European EN standards and the American ASTM standards for which we are accredited.

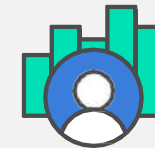





Frequently Asked Questions

- 1** **What is the validity of the inspection certificate?**

The validity is for 1 year, provided that during that period no repair or modification has been made to the installation.
- 2** **After the inspection, does the establishment need to conduct any further inspections?**

Yes, the establishment should conduct internal visual inspections daily and operational checks every two months.
- 3** **Does having a favorable inspection certificate for my facilities protect me in case of a potential accident?**

Yes, it provides the establishment with legal protection, avoiding liabilities for negligence due to non-compliance with regulations or poor condition of the facilities.
- 4** **How do I know which certifying entity to hire for the inspection?**

We advise that the entity has experience in managing leisure projects and water slides. Additionally, it should be formally accredited as an inspection body (ISO 17020) for the applicable EN and/or ASTM standards.
